I am pleased to inform you that you have qualified for Junior Research Fellowship (JRF) and eligibility for Assistant Professor in the National Eligibility Test (UGC-NET) conducted for December 2020 and June 2021 (merged session). The tenure of fellowship is five years and it commences from the date of declaration of NET result, i.e., 19-02-2022 (or) from the date of admission under M.Phil./Ph.D. (or) from the date of joining M.Phil./Ph.D. programme, whichever is later. The summary of financial assistance offered under the scheme is mentioned at Annexure I available on www.ugc.ac.in/netjrf

The Awardee is required to get admission and registration for regular and full time M.Phil./Ph.D. course in a University/Institution/College recognized by UGC at the first available opportunity but not later than three years from the date of issue of this award letter. University/Institution/College is requested to process for award of JRF based on this letter, in accordance with the procedure available on www.ugc.ac.in/netjrf.

It may be noted that the fellowship amount shall be disbursed through Canara Bank to bank account of the Awardee (any bank) directly. UGC has developed a dedicated web portal (<https://scholarship.canarabank.in>) for capturing data of the awardee. The Universities/Colleges/Institutions will link the data of the awardee with the master data on the UGC web portal with unique Maker/Checker IDs which have already been provided to them along with the passwords. The Universities/Colleges/Institutions shall update the information in the master data (regarding monthly payment confirmation, HRA, up-gradation, resignation etc.) of the beneficiaries on monthly basis. Based on the data updated on UGC web portal by the concerned Universities/Colleges/Institutions, the payment of the fellowship will be made to the beneficiaries (Detailed process available at https://www.ugc.ac.in/ugc_notices.aspx?id=2153).

It may also be noted that UGC has proposed to link "AADHAAR" with bank account of students so that there can be direct cash transfer and effective disbursement of fellowship into bank account of the student. In this regard, Secretary, UGC has already requested the universities to help students in Aadhaar enrolment vide D.O. No. F.14-34/2011 (CPP-II) dated 11.01.2013.

It may please be noted that the award is liable to be cancelled by Implementing/Awarding agency and it will also attract legal action against the Awardee in the following cases:

- If the awardee is found to be ineligible to receive the award at any point during the entire duration of fellowship,
- Misconduct of Awardee,
- Unsatisfactory progress of research work,
- Failure in any examination related to M.Phil./Ph.D.,
- In case any other fellowship is drawn from other source(s),
- Concealment of facts.

MEMORANDUM

The undersigned hereby refers to Mr. Amar Sharma Son of Sh. Ashok Kumar a post of Constable (General Duty) in the Ministry of Pw. 27/00 691007 in the Pay Matrix (Level-3) in Sahasra Shiksha Shal. He will also be entitled to draw other allowances, at the rate as applicable to Central Govt employees, subject to the conditions laid down in the rules and orders governing the grant of such allowances in the Force from time to time.

2. The terms and conditions of appointment are as follows:-

- i. On joining the Force, he/she will be governed by the Sahasra Shiksha Shal Act 2007 & Rules 2009, manuals & other instructions as issued and amended from time to time by the Government.
- ii. The appointment is purely temporary but may be continued. He/she will be on probation for a period of 02 (Two) years from the date of appointment. The competent authority as prescribed under SSB Rules may for the reasons to be recorded in writing, extend the period of probation for such further period or periods not exceeding two years or may during the period of probation, terminate his services without any gratuity. He/she permitted appointment in the past, however, will depend upon various factors governing terms of permanent appointment, to such extent as may be applicable.
- iii. He/she services on being a temporary Government servant shall be liable to termination at any time by a notice in writing given either by him to the appointing authority or by the appointing authority to him. The period of notice shall be one month; provided that the services may be terminated without any such notice and on such termination he/she shall be entitled to claim a sum equivalent to the amount of pay plus allowances for the period of the notice at the same rates at which he/she was drawing them immediately before the termination of his/her services or, as the case may be, for the period by which such notice has been given or given.
- iv. The competent authority as prescribed under SSB Rules may, having regard to the special circumstances of any case, permit him/her to resign from his/her term before completing the term of the engagement provided that while granting such permission the competent authority as prescribed may require him/her to return to the Government such amount as would constitute the cost of training given to him/her or three months pay and allowances, whichever is higher. Provisional further that he/she on resigning/retiring, for accepting a job under the Control or Basic Government and local bodies, after having been granted leave clearance for the same or who has completed ten years of service shall not be required to return the sum as provided here in Rule 6.
- v. On appointment he/she shall be liable to serve in any part of India as well as outside India.
- vi. He/she will be governed under New Continuously Flexible Scheme for job security benefit effective from 01/10/2014.
- vii. He/she will have to qualify Basic Recruit Training Course being conducted by Sahasra Shiksha Shal within a period of two years from the date of appointment. He more than the vacancies will be given to qualify Basic Recruit Training Course till up which vacant positions shall be liable to be terminated.
- viii. He/she will have to undergo various training courses, as may be prescribed, from time to time.
- ix. He/she will not be entitled to any Travelling Allowance/Dearness Allowance for joining at his/her first appointment.
- x. He/she should bring a Certificate from the local administrative authorities (The District Magistrate/Sub-Divisional Magistrate or any Officer superior to them in the State/Central Government), regarding his/her character and antecedents (as per format enclosed), which should have not been issued before seven months of date of joining.
- xi. The verification of Character and Antecedents shall be carried out immediately on joining from the concerned District Administration. In the event of any change in the personal information at the time of appointment in the service, he/she services is liable to be terminated without assigning any further reasons or without prejudice to such further action, as may be taken under the provisions of the SSB Act 2007 / Indian Penal Code for production of false certificates.
- xii. He/she has to maintain vigilance to the veracity of his/her all statements. The appointment is provisional and is subject to verification of Character and Antecedents (CAC) Certificate (if applicable). If the verification reveals that the claim belonging to Scheduled Caste/Scheduled Tribe or OBC or EBC category is not found true, he/she services shall be liable to be terminated without assigning any further reasons or without prejudice to such further action, as may be taken under the provisions of the SSB Act 2007 / Indian Penal Code for production of false certificates.
- xiii. For Other Backward Classes candidates the Community Certificate should invariably be issued by the designated authority only. If on verification, it is revealed that neither claim of belonging to Other Backward Classes nor that belonging to Creamy Layer is false, he/she services will be terminated (as per the provision) without assigning any further reasons or without prejudice to such further action as may be taken under the provisions of SSB Act 2007 / Indian Penal Code for production of false certificates.
- xiv. He/she should bring Verification Roll form (enclosed) obtaining signature with seal on the Verification Certificate by any Gazetted Officer mentioned in the schedule on page 4 of Verification Roll.
- xv. **women only (30% only)**: These women candidates will appear for joining in pursuance to the Order of Appointment and as a result of tests is found to be pregnant or 12 (twelve) weeks standing or over shall be declared "Temporary Unfit" and her appointment shall not be held in jeopardy until the pregnancy is over. She should be re-examined for a fitness certificate six weeks after the date of confinement, subject to the production of a medical certificate of fitness from a registered medical practitioner. These women candidates who is found to be pregnant or more than 12 (twelve) weeks standing will be allowed to do up to 100 days PRTD at the time of her joining. She will report back to her unit in case of an abnormal parturition.

3. The appointment will further be subject to:-

- i. The submission of a declaration about his/her marital status in accordance with the orders in force regarding appointment under Govt. of India that no person, who has more than one spouse living or who having spouse living in any case, shall such marriage is void by reason of the bigamy being during the term of such spouse, shall be eligible for appointment, confirmation, or employment in the Force. Any person who is not eligible to the SSB Act, who contracts or enters into a second marriage during the lifetime of his/her first spouse shall render himself/herself ineligible for retention in service and may be dismissed, removed or waived from service on ground of unsatisfactory conduct. Provided that the Central Government may if satisfied that there are sufficient grounds for so ordering, exempt any person from the operation of this rule. Therefore, in the event of having more than one spouse living, the appointment will be subject to his/her being exempted from the application of this rule.










